This team is made up of nearly 30 Independent Sector Leads covering 22 Local Authorities across Scotland. This is a national network of development staff with backgrounds in education, social care, health and the voluntary sector who work to ensure the effective representation of independent sector agencies within Health and Social Care Partnerships. PARTNERSHIPS

- Scottish Care works closely with partner organisations at strategic and practice levels on behalf of the membership to ensure that they can influence and be part of decisionmaking processes. These include:
 - Scottish Government and COSLA
 - Regulatory Bodies e.g., the Care Inspectorate, Scottish Social Services Council, and Disclosure Scotland
 - HEI's including Leadership on the Board of IMPACT, a multi-year newly funded ESRC evidence implementation academy in social care
 - Third sector organisations such as Tide, Alzheimer Scotland, Age Scotland, Life Changes Trust, Deaf Scotland and RNID.

- We are involved with partner organisations across the UK, Ireland and around the world, sharing intelligence and information to support the independent sector.
- Scottish Care has an Executive Committee comprised of key directors across both care home and care at home/housing support areas of the organisation. The Committee holds regular meetings throughout the year, including an annual general meeting, and provides oversight of all activities undertaken by Scottish Care; including the monitoring of the financial position of the company.
- We also have a strong National Committee which encompasses a comprehensive network of 40 Branch Chairs who host local branch meetings throughout Scotland for care homes, and for care at home and housing support providers. Led and chaired by Scottish Care members voted in by and for members in their local area, these meetings take place up to 4 times a year or more frequently depending on local issues of concern. Branch meetings are the perfect place to connect with local providers, discuss decisions and recommendations made about overall strategies and policies set by the Executive Committee of Scottish Care, in relation to priorities and projects set at local level. They are also the place to make recommendations to the Executive Committee in relation to wider issues of strategy and policy that are affecting members at that grass roots, local level.
