## FAQs

### Will I receive a delegate list for the conference?

Each exhibitor will receive a copy of our delegate list including all delegates who have chosen to be listed in accordance with GDPR. Please note that as ticket sales for this event take place right up until the event date, the delegate list will be sent at the end of ticket sales to ensure all details are included.

### Are refreshments provided at the conference?

Yes, event passes and refreshments are provided on the day for **two people per exhibitor stand**. Exhibitor lunches will be provided outwith delegate break times to ensure you can maximise networking opportunities during delegate breaks. **Please note that for health and safety reasons as well as catering numbers, we require notice in advance of the event date of any additional people you would like to include with your stand on the day, and additional charges apply.** Thank you for your understanding and assistance.

### Can the venue accept deliveries for the event in advance?

The Radisson Blu will accept deliveries up to 48 hours ahead of the event. Details for this will be provided in advance.

### Is there access to set up available ahead of the event date?

There is no access to set up ahead of the event date due to other bookings in the hotel. Access to set up will be from 06.00 on Friday 19th May, with de-rig to be completed immediately following the close of conference at 15.30.

### Does the venue have parking facilities?

Parking is not available onsite at the hotel, however there is an NCP car park located around the corner from the venue. Please note that parking tariffs apply at all times.

### Can I arrange overnight accommodation at the venue?

Any arrangements for overnight accommodation should be made directly with the Radisson Blu, and we can provide contact details for you if required.

### Does my exhibitor booking include tickets to the evening awards dinner?

No, exhibitor packages do not include tickets to the evening awards dinner, and these must be booked separately and in advance of the event. Please note spaces are limited for the evening awards, and if you would like to receive details for this once available, please advise. Evening Awards tickets do not include access to the main conference.

### What COVID health and safety measures will be in place?

Any health and safety measures in relation to COVID will be advised ahead of the event. Our team continue to monitor this very closely, and we will continue to follow health and safety and government guidance. We will keep all event sponsors, exhibitors and attendees updated with measures in place at the earliest opportunities, and thank you in advance for your support.

### What will happen if the event is unable to go ahead on the planned date?

Should the event be unable to go ahead on the planned date, we will advise at the earliest opportunity, and refund any payments received for sponsorship and/ or exhibitor stand bookings. Please note that Scottish Care does not accept liability for costs outwith these packages, and we would highly recommend checking the terms and conditions for bookings/ items you may be securing outwith our packages (e.g. hotel bookings, travel, items for your exhibitor stand etc). In the event of cancellation, we will endeavour to rebook an alternative date if possible, and sponsors/ exhibitors for the original event date will be offered priority booking.



### **Exhibition/ Conference Sponsorship Booking Terms and Conditions:**

- Payment in advance is a precondition of attending Scottish Care events. For any stand space/ sponsorship not paid before Friday 28th April 2023, the company will not be permitted to exhibit on the day and the space will be offered to companies on our waiting list. No refund will be paid to companies failing to attend on the day.
- Scottish Care is committed to ensuring the safety of all event attendees, our social care sector and the wider community, and will continue to follow government guidance and health and safety advice in relation to this event.
- In the event of cancellation of the event, Scottish Care may rebook an alternative date, or host a virtual event. Exhibitors will be refunded in full for any payment made for the exhibition stand fee for the original date, and contacted to advise of alternative plans. Scottish Care does not accept liability for additional event costs outwith the fees for exhibitor stands or sponsorship packages paid.
- Companies confirming a booking for the event agree to abide by exhibition protocols. This includes any COVID health and safety measures in place, and these will be advised in advance of the event date.
- Companies should advise preferred stand location at the time of booking, and no booking is confirmed prior to the return of a booking form. Exhibitor stand locations will be as close as possible to those noted on hotel sample floor plans, however please note these may not be to exact scale.
- Companies may only set up/break down stands prior to commencement and after close of conference. Access to set up on the day is from 06:00, with set up to be completed ahead of delegate arrival from 08:30. De-rig is immediately following the end of the main conference at 15:30.
- Exhibitors must contain displays, equipment etc, within the confines of their allocated space. Exhibitors who disregard this instruction will be asked to remove the items prior to opening of conference. Standard space is open tabletop, 3m x 2m, with table, 2 chairs and access to power socket. No walled areas are available to use
- Catering and exhibitor passes are provided on the day for up to two people per exhibition stand. Should you wish to have more than two team members for your stand, we require advanced notice for both catering numbers and health and safety reasons, and additional charges for extra people will apply. It is essential to book additional team members attending ahead of the event date as we may be unable to accommodate additional people on the day.

- Payment in advance is a precondition of attending Scottish Care events, and payment is due before Friday 18th April 2023
