1) Research in care homes - an interactive workshop -Enrich Scotland - Dee (Level 3)

# 6) Ethical Commissioning: Improving and Sustaining Practice — John Skouse, Care Inspectorate and Benjamin Cooper & David Jack, Fraser of Allander Institute — Don (Level 3)

The delivery of rights based; person led care is dependent on the how it is commissioned and procured. Yet across the country, we see chronic undervaluation and underinvestment of the independent care home sector, pushing providers to edge of financial viability.

This joint session will explore improving and sustaining ethical commissioning practice at partnership level. This includes an examination of the prevailing cultures across partnerships, the symbiotic relationship between commissioning and procurement, adherence to the principles of choice and control, and the role of research and data in meeting demand for services during times of reduced expenditure.

### 7) Empowering Care Home Staff for Improvement: A Supportive Program for Lasting Change. –
